



## MEMORANDUM OF UNDERSTANDING

**BETWEEN** 

## TEXAS A&M UNIVERSITY-CORPUS CHRISTI

AND

## NHA TRANG UNIVERSITY

This agreement is made and entered into on the date of the final signature hereto, by and between Texas A&M University-Corpus Christi, a member of The Texas A&M University System an agency of the State of Texas, United States of America, located at 6300 Ocean Drive, Corpus Christi, Texas 78412 (hereinafter referred to as "A&M-CC") and Nha Trang University located in No.2 Nguyen Dinh Chieu Street, Nha Trang City, Vietnam (hereinafter referred to as "NTU").

- 1. **A&M-CC** and **NTU** desire to engage in cooperative educational and research activities for the mutual benefit of both institutions. The parties agree as follows:
  - a. The parties will jointly develop cooperative educational and research programs for faculty and students of the two institutions within the framework of this agreement. The cooperative activities to be covered by this agreement may include faculty and student exchange, joint degree, study abroad, collaborative research programs, seminars and workshops, and service programs.
  - b. Each activity to be performed under this agreement will be undertaken pursuant to an addendum that will contain the specific terms and conditions governing the activity. The terms and conditions will be mutually agreed upon by the two institutions on a case by case basis in writing.
  - c. Each institution will be responsible for seeking funds to support its involvement in the cooperative activities contemplated under this agreement, and all such activities will be dependent upon budgetary appropriations of the parties.
  - d. All activities developed hereunder will be in accordance with all applicable rules and regulations of the home and host institutions, and all applicable federal, state, and local laws, rules, and regulations.

e. The following individuals will serve as the designated coordinator responsible for the development and implementation of this agreement.

The individuals executing this agreement on behalf of each party represent and warrant that they are each the duly authorized representatives of such party on whose behalf the individuals are signing, each with full power and authority to bind said party to each term and condition set forth in this agreement.
