



### MEMORANDUM OF UNDERSTANDING

#### **BETWEEN**

# KARPAGAM ACADEMY OF HIGHER EDUCATION, COIMBATORE, INDIA

### AND

## NHA TRANG UNIVERSITY NHA TRANG, VIET NAM

This Memorandum of Understanding is made by and between Karpagam Academy of Higher Education and NhaTrangUniversity, hereinafter referred to as "KAHE" and "NTU."

- 1. KAHE and NTU hereby agree to encourage academic cooperation through Research and Study to furtherance of the advancement of learning as stated below:
  - (a) To encourage visits by faculty from one university to the other for the purpose of engaging in teaching and research;
  - (b) To facilitate the exchange of qualified students from one university to the other for the purpose of upskilling in undergraduate and graduate programs as non-degree seeking exchange students;
  - (c) To foster the exchange of academic publications and scholarly information; and
  - (d) To promote other academic activities which enhance the aforementioned goals.
- 2. Both universities acknowledge that the visit by faculty and students from one university to the other shall be subject to the entry and visa regulations of India and Vietnam and shall comply with the regulations and policies of KAHE and NTU.

- 3. Both universities agree that all expenses, including research material, international and domestic travel, per diem, honoraria and all other costs, shallbe the responsibility of the participating scholars and determined on a caseby-case basis and agreed upon a mutual written consent of the parties. However, each side will make its best efforts to make available university accommodation to visiting faculty and students.
- 4. This Memorandum of Understanding between the KAHE and the NTU will be enforced on the date of signing and will remain in force for three (3) years.It shall be automatically extended at each expiry date for an additional duration of three (3) years unless either party gives the written notice of termination of this Memorandum of Understanding six (6) months in advance.
- 5. Both universities agree that this Memorandum of Understanding is incorporated into, and will provide the foundation and framework for, projects developed by academic and administrative units from the two universities and documented in other subsequent Agreements.
