

MEMORANDUM OF AGREEMENT (MoA)

BETWEEN

NHA TRANG UNIVERSITY - VIETNAM

AND

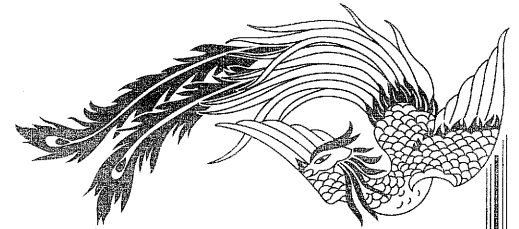
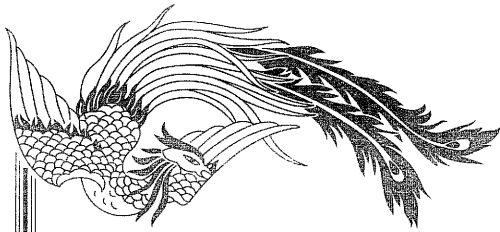
HANSEO UNIVERSITY - KOREA

Nha Trang University (NTU) and Hanseo University (HSU) enter into this agreement to foster international cooperation in training, research and development activities in the areas of mutual interests.

The parties agree to encourage the following activities in particular to promote academic cooperation during a five year term, from 2013 to 2018:

- **Institutional exchanges between faculty and staff from each partner institution**
 - HSU will invite NTU's teaching staff to give short course at HSU.
 - The request will be sent to NTU in during December each year.
- **Co-operation in any other areas as agreed to by the parties from time to time**
 - HSU will cooperate sending students, especially in leisure sport field, to NTU for short course.
- **Acceptance of undergraduate and graduate students of each partner institution for periods of study and/or research**
 - NTU and HSU agree to develop 2+2 bachelor training program or 2+3 master training program. The two parties will exchange the curricula and design the programs.
- **Exchange knowledge and technical Know-How**
 - NTU and HSU will cooperate in maritime sports and designing some models for ship or boat.
- **Co-operation in any other areas as agreed to by the parties**

Before specific activities can be implemented, the parties shall develop and enter into specific activity agreements based on the form of implementation mutually agreed upon subsequent to this MoA. Implementation of specific collaborative programs will depend upon the availability of funds and continued mutual interest of the partners.



Both institutions subscribe to a policy of equal opportunities and will not discriminate on the basis of race, gender, ethnicity, religion, national origin, or disability.

The MoA becomes effective on signing. It shall remain in force for five (5) years and may be renewed by the written agreement of the parties. The activities undertaken based on this MoA should be evaluated and lessons learnt used to improve the effectiveness of the cooperation. The MoA may be terminated by either party upon at least 90 days advance written notice. Such termination shall not affect activities in progress at the time the notice is received.

This MoA constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or written, are hereby merged into this MoA. This MoA is not considered a binding contract creating legal and financial relationship between the parties, but is designed as a means to facilitate and develop a genuine and mutually beneficial process for collaboration. This MoA is signed in two identical copies in English and both copies being valid.
